When Will the Change Take Place?

1. Change applies to the 2023-2024 grant cycle

- 2. Application portal opens for 2023-2024 Grants <u>on or after</u> 9/22/2022 – <u>open for 60 days</u>
- 3. All current grantees <u>REQUIRED</u> to <u>register an account and submit a</u> <u>grant application for 23-24 in new system</u> during the application window regardless of your status this year (Awarded or Renewed Grant)

Scenarios – 96 <u>Awarded</u> Grantees Seeking Renewal

- 1. Awarded Grantee wants to create a "cloned application" but for a different total amount. Will not be considered.
- 2. <u>Awarded Grantee</u> wants to create a "cloned application" but for a different service category. Will not be considered.
- 3. Awarded Grantee wants to create a "cloned application" but for grant that is on renewal track but wants to apply for a SECOND GRANT in a different program.
- 4. <u>Awarded Grantee</u> wants to create a "cloned application" but wants to change the budget (more staff, more salary, more client services, less other direct, etc). AMENDMENT
- 5. <u>Awarded Grantee</u> wants to create a "cloned application" but wants to add/subtract counties to be served, or veteran discharge statues, or add/remove dependents & surviving spouses. AMENDMENT



What Will be the Impact?

1. <u>No impact</u> to current (2022-2023) grantee operations. Monthly PRRs, monthly progress reports, and quarterly outcome measures will still be completed and submitted via the current method.

2. At the end of this grant year, CLOSEOUT must complete by the deadline (August 31, 2023) because transactions cannot be performed in the current system after August 31st.



How to Prepare?

- 1. The new system is designed to have specific "moderators" for each organization. The moderator is essentially an account administrator, who will have the ability to add additional users from the organization.
- 2. To prepare for your account registration, identify who within your organization will serve as the primary and secondary moderator.
- 3. Your moderator will be the person who:
 - Initiates the registration IN THE NEW SYSTEM for your organization (the <u>FIRST PERSON</u>)
 - Completes your organization's registration and ensures the organizational profile information is correct
 - Identifies/creates additional users for your organization such as finance staff, signature authority, grant writers, and contracted persons assisting with the creation of your application.
 - Creates the application based on the opportunity grant program and service category


