findings, an overall rating of strong, follow-up procedures in June over findings identified in prior internal audits, and a full risk assessment update."

IV. REPORTS

- a. Report on Agency Departments and Programs.
 - i. <u>Program Operations Division</u>. Charles Catoe, Division Director of Program Operations, provided the Commissioners with the T.V.C. Agency reconstitution updates and department updates.
 - 1. **Reconstitution Report.** Charles Catoe, Division Director of Program Operations, gave a detailed report to the Commissioners of the latest Texas Veterans Commission reconstitution updates.
 - 2. Department Summaries.

Veterans Employment Services: D.O.L. Grant Audit completed. Informal feedback indicates a few corrective actions will be required, but the case file audit resulted in 100% compliance. A lot of training is being conducted.

Claims: Most offices are open. They are taking appointments both virtual and in person. March 2022 Claims customer numbers were up over 20% from the March 2021 customer numbers. Additionally, Claims are moved to a state work queue for virtual appointments; this opens up virtual appointment availability since the meeting can be scheduled anywhere in the state. Claims new Operations Manager – Gary Ivy, prior N.W. District Manager.

Health Care Advocacy: They accomplished four district training's in April. *Veterans Education*: The response letter from the Veterans Administration regarding the appeal. T.V.C. succeeded in the appeal request, and the rating was upgraded to a Satisfactory. A new Veterans Education Director was hired, David Salgado. He comes from Utah, where he was the Utah State Approving Authority for the last couple of years.

- ii. <u>Resource Management Division</u>. Chip announced the new Veterans Entrepreneur Director, Megan Tamez. Additionally, this year in V.M.H.D. We added a couple of Homeless Coordinators, and now we've also added a Suicide Prevention Coordinator.
 - Appropriation Year 2022 Second Quarter Operating Statement: Michelle Nall, C.F.O. of the T.V.C. Finance Department, gave a detailed brief to the Commissioners on the Appropriation Year 2022 Second Quarter Operating Statement.
 - 2. *Fund for Veterans Assistance Grantee Search Tool Initiative*: Elisabeth Webster, F.V.A. Communications Coordinator, briefed the Commissioners on a brief demo of the Veterans Interactive Services Directory.
 - 3. T.V.C. Survey of Employee Engagement: Tina Marberry, Director of Human Resources, briefed the Commissioners on the results of the Employee Engagement Survey discussed during our recent Agency-Wide Communication. These results reflect the perceptions of each T.V.C. employee that responded. The agency's overall score improved from 392 (2020) to 408 (2022). Scores above 400 are the product of a highly engaged workforce. T.V.C. improved in every category except the perception of pay; however, T.V.C. has given a majority of employees pay increases each year.

 - Washington, D.C. Lastly, Gabe Torres is transferring to Health and Human Services.
 ii. Women Veterans Day Event: Dr. Krystle Matthews briefed the Commissioners on the upcoming Texas Women Veterans Day 5k run at Camp Mabry on Saturday, June 4, 2022.
- c. <u>Executive Director Report</u>. Thomas Palladino, Executive Director, provided a report on the agency's priorities and activities over the last quarter, including meetings and events he has attended to include relationships with other state and federal veteran agencies. Provided a summary of V.A. Recommendations to the Asset and Infrastructure Review (A.I.R.) Commission. The VA Recommendations to the Asset and Infrastructure Review (A.I.R.) Commission for the Veteran Integrated Service Network (V.I.S.N.) 16 and 17, located in Texas. The A.I.R. Commission will then provide their recommendations to Congress, who will make all final decisions on these facilities.

Mr. Perez Jr. will serve the remainder of Melissa Castillo's term ending December 31, 2024. However, he will also be eligible for reappointment to serve an additional 4year term ending December 21, 2028.

A copy of the notice of adoption will be published in the Texas Register upon commission approval. After adoption by the Commission, the rule will take effect 20 days after the date it is submitted to the Secretary of State.
