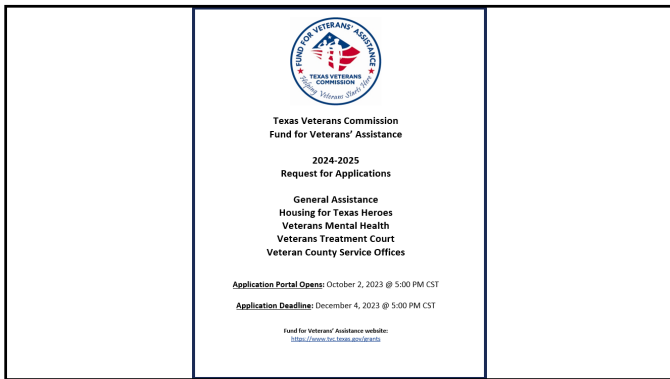

**Awarded vs Renewed**

- 4.8.6 Organizations that are **currently providing services under a non-renewed grant during the 2023-24 grant period**, have an **opportunity to meet renewal criteria for a 2024-25 grant**, and **therefore are ineligible to submit applications for the same grant programs** announced in this RFA.



### How Much \$ Can Apply For

---

**Section 4. 2024-2025 Funding Opportunity and Application Submission Requirements**

- Grant amounts must be requested in increments of \$5,000
- VTC grants limited to \$300,000 for one county and \$400,000 for regional courts as certified by state.

FVA Grant Amount	Minimum Required Financial Documentation
\$150,001-\$500,000	Independent Audited Financial Statements not older than 2 years
\$50,001-\$150,000	IRS Tax Form 990 showing Part X Balance Sheets not older than 2 years
\$5,000-\$50,000	IRS Form 990 EZ not older than 2 years

Organizations submitting two applications totaling \$750,000+ must provide their most recent A-133 single audit not older than 2 years

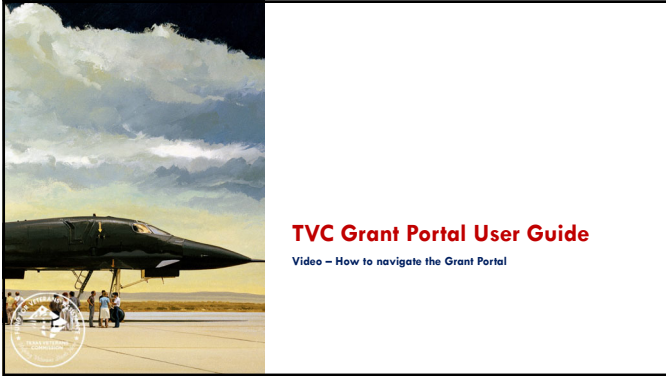

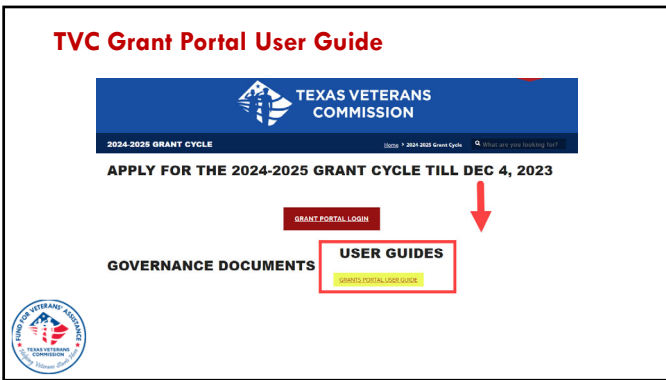

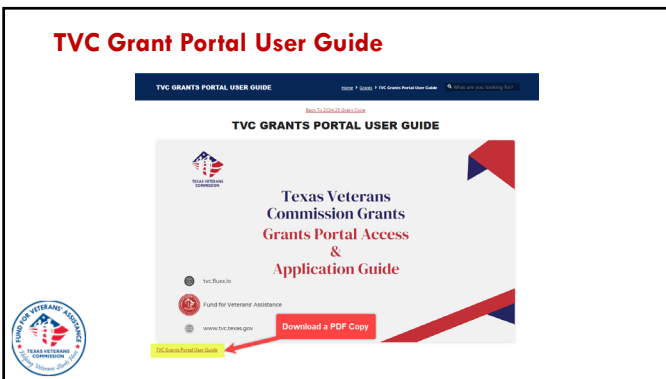

### TVC Grant Portal User Guide

#### Phase I: Registration


Follow the steps below to create your new account in the grants portal.

**03 1. Creating an Account**

To access the TVC Grants Portal, type the URL into your browser's URL address bar. Click on the "Create an account now" button on the right hand side of the screen. This will take you to the next screen, which is the eligibility quiz.

The moderator will be the first person to initiate the registration, and the secondary moderator will register after this.

Registration should ONLY be done by the primary and secondary moderators. No other users should attempt to complete registration.

### TVC Grant Portal User Guide


#### Phase II: Account Setup - Users

Once you are logged in, you will be required to provide additional information and upload supporting documentation to your user profile. You will be able to provide this information by editing your profile and submitting it for approval.

**04 1. User Profiles (People Card)**

The first step in updating your information should be to provide the pertinent details on personnel, beginning with the primary. Contact you provided during your registration. To do this, you will need to navigate the tab labeled "people" on the left-hand side of the screen. These tabs are referred to as "cards" in the system.

Whenever a status of "More - Additional Details Required" is showing, moderators must check the profile and ensure all mandatory fields are filled in.
