IV. Report, presentation and/or action on agency programs and divisions:

- A. Program Operations Division:
- B. Resource Management Division; and
- C. Deputy Executive Director.

The Commissioners reviewed the Quarterly Program Reports that were previously provided. Directors were provided the opportunity to brief the Commission on any new items or highlight significant items that occurred within their program or division.

A **Charles Catoe**, Director of Program Operations, reported the 15 of the 19 Claims Representatives have been hired and are planning to have all 19 hired before end of year. We are also funding a second Justice Involved claims person to be hired soon and Wes created and approved a new position for a Claims Inquiry Coordinator to follow up on legislative and everyday claims inquiries. Texas Workforce have a new system that incorporates our veteran's information to their database, but it is currently facing issues and the Workforce Commission is working on fixing the issues.

Charles Bryant, Interim Operations Manager of Veterans Education, during FY19 and continuing to this quarter Veterans Education has worked on several items related to GI Bill benefits and program approvals, some highlights that we have done is we have contacted 900 facilities throughout the state referencing the implementation of the Choice Act section 103/107, effective August 1, 2019, schools are not allowed to penalize or prohibit a GI Bill student from attending or participating in courses while awaiting VA payment (for up to 90 days).

Gary Lee, Health Care Advocacy Program Manager, provided a brief summary of the what the program did closing out FY19, resolved over 7500 healthcare related cases, this success can be attributed to our training program that was put in place; usage of a training checklist and mentor system to ensure the staff knows what they needed to do when serving veterans. Conducted 718 outreach events, exceeding our goal of 610, had the opportunity to engage with over 16,000 veterans based on these alone.

B. **Chip Osborne**, Director of Resource Management, wanted to say a special thanks to Tish McCullough for her service as our Director of Mental Health, she was with our agency for 5 years, we wish her all the best with her new job and new endeavors and she will be sadly missed. She was recognized and given a certificate at our last Employee Recognition event. Ron Scoggins will be the Interim Director; Human Resources is working on posting the new position. Also, I want to thank Veteran Employment Services Department for supporting Anna Baker and the Veteran Entrepreneur at the Governor's Small Business Forum in El Paso, with special speaker Chair Ruth Hughes from the Texas Workforce Commission.

Tina Marberry, Director of Human Resources, started on November 1st of 2019 and will also have the Training Events Management Program under her leadership. I have been meeting with other Directors to see how we can partner together as a team and figure out ways to improve our policies, procedures and functions in our CAPPS processes. We are in the beginning stages of planning a visit with leadership and administrative teams throughout the state providing them 1 on 1 HR training for HR processes. Our 4th Quarter current turnover rate is 5.4% which is a little higher than what we would like to see but overall for the year we are 15.4%.

Elisabeth Webster, Communications Coordinator, Funds for Veterans Assistance gave an update on the Tour of Texas. Visited every single region in Texas, total of 8 to include, Panhandle, West Texas, Alamo, South Texas, Gulf Coast, Central Texas, East Texas and North Texas. Also, I would like to point out, we represented every branch of service during this coverage. Chairman Cantu thanked Elizabeth Webster for a job well done and putting in the hard work.

C Shawn Deabay, Deputy Executive Director, provided an update regarding Sunset Deliverables and a couple of updates from the IT department. I want to thank Cruz Montemayor for putting the Sunset Deliverables together along with the Government Relations team and all of the programs that participated. 1st Table SB601 shows the exact language on what we need to accomplish according to that bill. Status is green or yellow and to the right is a detailed description of where we are in the process. 2nd Table Management Action, indicates we are in

compliance, but are continuing to improve the process.

Greg Talamantez, Manager of Government Relations, updated the Commissioners with the latest Interim Charges to include VABS Veteran Treatment Courts, Veteran Health Care and Veteran Mental Health.

Quarterly Reports from Advisory Committees (Veterans Communication, Veterans \mathbf{V}_{\star} Employment and Training, Fund for Veterans' Assistance and Veterans County Service Officer)

- Communications Advisory: Elaine Zavala, Director of Communications, gave a brief overview of activities; Met July 19 but did not have a Quorum, canceled due to Staff Conference, had 2 RSVP.
- Veterans Employment and Training: Tim Shatto, Director of Employment, gave a brief overview of activities.
- Veteran County Service Officer: Ted Oats gave a brief overview of activities, there was a shaky start to this FY but it got worked out. A better product was created and focused on the Training Conference.
- Funds for Veterans Assistance: Jim Bracken, Director of FVA, gave a brief overview of activities for the 4th Quarter.

VI. Report, presentation and/or action regarding Regular Evaluation of Advisory Committees.

Shawn Deabay, Deputy Executive Director, briefed the Commissioners on recommendations from TVC staff concerning the advisory committees. These Committees have been very dedicated to Texas veterans and the agency and work extremely well together. However, there are three pervasive and recurring issues which have lent to the staff recommendation to dissolve the two committees:

- Irregular participation and frequent rescheduling due to a lack of a quorum.
- There are very few overall outcomes in either committee in comparison to the resources expended.
- Cost and legal exposure. The agency expends tremendous resources on conducting the quarterly meetings in staff hours, training, and travel costs.

Based on the self-assessment and interviews conducted, there are three proposals for the commission to consider regarding its advisory committees:

- (1) Combine the communications advisory committee with the veterans' employment & training advisory committee into one advisory committee, which would concentrate on the overall needs of veterans in the state of Texas:
- (2) Eliminate both the Communications and Veterans' Employment & Training advisory committees: or
- (3) Retain each advisory committee "as is."
